Background and Experience

Please briefly present the organisation.

Muhu Noortekeskus is a local municipality owned open youth center on the island Muhu in Estonia. The youth center was opened in 2005 and since then has been developing youth work on the island.

Daily we work with the pupils of Muhu Middle School. But as the only youth organisation on the island of Muhu, the youth center also coordinates youth work in the municipality. Social inclusion is very important for our youth center, since we are the only youth work organisation on the island, all youngsters that live here have to feel included on a daily basis. The organisation has a very strong multimedia backround and it's own recording studio.

This project is the first independent step into the world of Eramus+ projects.

What are the activities and experience of the organisation in the areas relevant for this application?

Muhu Youth Center has had on small recording studio since 2011. When the new house was built, a big top-notch recording studio was built with it. The youth center has provided informal education in the multimedia field for a decade. All the technical knowledge and equipments are available to carry out the project.

People that work in the youth center at the moment, don't have much experience in international youth work, so this is a great teaching opportunity for the team.

Liia Ots is the manager/youth worker of the organization is the project leader. She has worked as a youth worker for 1,5 years. She has a higher education in Social work and rehabilitation administration. She has a lot of knowledge how to work with the inclusion target group. Before entering the youth work field, she was a child protection specialist. She has done different projects for 10 years. But, she doesn't yet have experience in youth exchanges, so this is a new learning opportunity for her.

Maret Voites works as a youth worker in the youth center. Maret started to work in the youth work field in january this year, but is a certified midwife and has worked with youngsters for a decade. She also still is a facilitator in the medical field and brings knowledge of how to get a topic across to other people.

Renat Ränk has been a musician for about ten years. He works as a band teacher in the youth center and also has knowledge about recording.

Arnek Grubnik is the mediaclub teacher in the youth center. Arnek has worked has a youth worker for 13 years. He himself learns about graphical design and knows a lot about movie editing.

Background and Experience

Please briefly present the organisation.

Latvijas Neredzīgo biedrība or Latvian Society of the Bling (LNB) is the biggest and oldest NGO in Latvia that represents the interests of visually impaired and bling people in Latvia.

Latvian Society of the Blind unites more than 3000 people in 9 biggest towns in Latvia. Organization's aim is to unite blind and visually impaired people and to provide them with the necessary support, helping them with their day-to-day life and integration.

Main tasks are:

- 1) Represent and protect the interests of people with sight disability in different government and municipalities' organizations;
- 2) Develop and manage social rehabilitation programmes;
- 3) Encourage professional training and improve employment rates.

What are the activities and experience of the organisation in the areas relevant for this application?

The past 2 years LNB has focused on working with our youth, members up to 30 years old. In 2019 LNB participated in 3 Erasmus + projects:

- 1) in May 3 youngsters and a group leader with sight disability went to Turkey to participate in
- a project "remove all obstacles through sports", leading partner organization "Talking hands", Turkey.
- 2) From April till August LNB was a leading partner in a youth exchange project "Don't be afraid to dare in the dark". In this project 20 youngsters with sight disability from Sweden and Latvia participated.
- 3) From September till December LNB organizes a local project in KA3, where 11 LNB youngsters learned how to debate and participated in public debates with lawmakers.

Apart from the projects LNB has been working on reactivating the youth organization, that historically existed to create a safe and fun place for young people with sight disability.

Background and Experience

Please briefly present the organisation.

NUM (IYA) is the youth organisation that works with and for young people in our local community. Currently the Association has over 70 members from wider Lepoglava area due to the latest membership changes. NUM (IYA) has implemented over 200 actions, event and projects in Lepoglava and wider area. Beside in Lepoglava region, the Association cooperates with other similar associations and organizations in Croatia. Projects of this Association are referring to all aspects of social life, from education, informing and sport to ecology, concerts and exhibitions. From the beginning the Association is active on the field of designing and implementing different projects funded by local and regional government, national funds, different ministries, foundations and EU funds. Besides projects, the Association is organizing various activities and events (sports, informal education, quiz, festival, workshops) of which the most famous is Jailhouse festival. The festival is organized every year in August, continuously from year 2010. It provides a handful of entertainment and sporting events, education and workshops for children and youth, enriches the social life of community and encourages young people in active participation in community.

From founding the organisation till now, NUM (IYA) implemented over 100 different projects and activities. Programs are mainly focused on needs of youngsters in our region. We are also implementing activities through which young people directly influence and participate in the development of local communities. In our activities we cooperate with local governments, public institutions, private sector and other NGOs. Vision of NUM (IYA) is "Educated young people who actively, responsibly and equally participate in the socio-political life of local community" while the mission of NUM (IYA) is to promote active and responsible participation of youth in the life of local communities, and advocate the interests of young people in local authorities. The association encourages the development of local youth policies through the development and implementation of local policies for young people and strengthening the capacities of young people through education, collaboration, partnerships and information. Our organization was also included in Eurodyssee program which is one of the most known programs for youth to get some experience and skills in another country. As well, NUM (IYA) was Eurodesk multiplicator and has an EVS accreditation for sending, hosting and coordinating.

What are the activities and experience of the organisation in the areas relevant for this application?

We as an organisation been involved in organizing Training courses on a European Level for some time. A big number of our members, including previous vice president of the organisation, have been working in the field of youth work for a number of years. Previous vice president and currently an active member of the organisation was working within an informal group and he was making use of Youth in Action and then Erasmus+ in his work with the people. As we are active in the Erasmus field and have been since the early days of the programme, we're constantly implementing projects and activities that are about inclusion and intercultural learning and we're trying to give young people from our city and Croatia but other countries that we agree partnerships with as well, the opportunity to be a part of the programme, to learn, to feel included and to promote the values that they encounter and learn about in the future. As a youth group we have been active in our community and also on a national level for over 17 years now. We have actively taken part in the running of our community. As a youth organisation we are more focused on things and issues related to youth and we have actively taken part in the creation of different youth policies. On a local level we have been actively organising activities for young people including activities that helped the community like clean ups and refurbishment of public places. The last thing that we refurbished was the sports centre that was abandoned. Thanks to our young people and their work, the people of Lepoglava can once again start enjoying these facilities. These are some of the activities that we did that are directly related to active citizenship. Apart from this we are continuously organising other activities and workshops.

As we are empowering young people to become active citizens, we have managed to have young people that after their experience with NUM, they decided to do more on the level of active citizenship. For example, one of our past members, Hrvoje Kovac is now the Vice-mayor of our town. We believe that if we instill this idea and sense of active citizenship, in our young people the young people will become more active in their community and the whole community will benefit.

This will also serve as a capacity building opportunity for our organisation as after this project we will have another person experienced in the successful implementation of Earsmus+ projects.

Mario Zulicek: Mario is an active member of our Ngo and has also been the vice-president of our organisation for 5 years. Although at the moment he is not any more in that position, he is still an active member of our organisation. He decided not to be the vice-president anymore so as to give the space for new young people to be actively involved and share their ideas. However, he is still active and he will be making sue of his vast experience in youth work, Erasmus+ and project management to help implement another successful project.

Mihaela Spiljak: At just 18 years of age, she has already 3 years of volunteering experience within our organization. She's been involved in different projects at a national level and she is starting to build her skills and experience on a European level through Erasmus+ programme. She has voluntary experience in the field of youth work and is often included in organization of various activities. As young as she is, she's already one of the highly engaged members in our association.

Background and Experience

Please briefly present the organisation.

The youth division is part of Culture and Leisure Sector of Helsinki city. The Youth Division has a budget of approx. 30 million euros, 300 youth workers in about 60 locations and youth houses around the city. Last year there was aprox. 1 400 000 annual visits to our premises or contacts outside them and over 2000 different hobby groups. The mission of the Youth division is to support young people's life choices and their sense of responsibility as well as to increase their participation. In the first place, this means creating the space for moral and ideological growth; secondly it means facilitating their skills, motivation and experiences in civic interaction, and thirdly it means shouldering responsibilities for young people's social risks and place in society. We aim to do more where more is needed and with those who need more. We are a knowledge based youth division, so we follow both statistics and research as well as we do a lot of research and surveys ourselves. Targeted youth work (young people at risk) is carried out together with Social Services NGOs and education sector.

We want all young to have a friend, to feel important and have a hobby. Our goal is to provide universal services for all young people: the entire city is a nice place for young people. Our aim is to provide power and responsibilities for the youth. To ensure they have a voice, especially in issues related to youth. We also want to provide different projects, programs and spaces where the youth can make their dreams come true. We want the youth to find friends, have hobbies and fulfill their dreams, make projects and in this manner learn a lot, so-called non-informal learning. One of our goals is that every teenager has a democratic experience through participatory budgeting and activist groups.

What are the activities and experience of the organisation in the areas relevant for this application?

Our main idea is to participate into this project with Sankarit –activities ('Sankarit' means 'Heroes'). Sankarit –activities are part of the Youth services and they offer free time activities / hobbies for youngs with disabilities and special needs between of ages 15-29. For these activities, it would be very important to participate into this kind of international youth exchange that supports inclusion and offers a special opportunity for youngs with mental disabilities to travel abroad. It has been a wish that has come from the youth and for the first time we have an opportunity to start to work out with this.

Please give information on the key staff/persons involved in this application and on the competences and previous experience that they will bring to the project.

The key person of our organization has worked as a leader in charge with Sankarit –activities last three years and before that a long time as a part time worker with these activities. There is also a lot experience with cultural youth work and art based methods and that supports very well the themes of this project. The main competencies are an ability to coordinate and lead the group of young people, organize activities together with youngs and create a safe and communal space for everyone.

Project Description

Why do you want to carry out this project? What are the objectives of your project? How does it link to the objectives of the Erasmus+ programme and this specific key action? What are the issues and needs that you are seeking to address through this project?

The projects main objective is to include youngsters with fewer opportunities and give them a sense on empowerment through the thrill of success. In the project we will have youngsters with different backround and obsticles in life. In the project the participants will be young people with sight disability from Latvia, young people with mental disabilities and special needs from Finland and youngsters who have complicated social, economical and geographical backround from Estonia, plus your everyday youngster from Croatia. They will all address the subject of confidence and self-powerment through music and multimedia. During the youth exchange they will create and record music and make a music video for the song. The different backrounds of the participants will help the youngsters to find out more about inclusion and about their own strengths and the struggles of other youngsters in Europe.

The project takes place on Muhu island in Estonia, where there isn't much diversity, so the project will improve the knowledge of inclusion on the island and local community as well. The Finnish, Estonian and Latvian group leaders don't have much experience with youth exchanges, so the project helps to improve youth work in the organisations of the participants through experience.

How was the project's partnership built up?

The Finnish, Latvian and Estonian partners met during the SPI Matchmaking in Frankurt in October 2019. We came up with the idea for the project and worked on it in Frankfurt. At home ach organisation presented the idea to their youngsters, who then gave input in the actual content and planned activities during the project. All the young people, that heard about the project, were very interested in it and wanted to be a part of it.

The Croatian partner was added later, when the group leader of the Estonian organisation, Liia attended a study course in Croatia and when she started to talk with NUM about other projects each was doing, this particular project was something for NUM to be a part of.

Since NUM will bring experience to the project, they are a valuable partner for the less experienced partners.

Does your project involve participants facing situations that make their participation in the activities more difficult?

Please give information, for each activity, about the profile/background of these participants and how they will be involved in the activities.

In the project there will be blind and visually impaired young people from Latvia. They will be accompanied by two assistants, who will help them get around and participate in activities. Most of the activities don't need any special preparation, but activities like recording and editing audio and video will need some adjustments. The young people will use special talk back programs, that assist with navigating computers. However one of the aims for visually impaired and blind students in this project is to test what can they do in terms of recording and editing audio and video. Recording them is manageable with assistance from other participants and assistants, but the editing bit is the one they are most interested in. Since it is possible that not all the participants will be able to do all the activities and tasks, it is planned to have multiple group activities at the same time, so that each participant can have options and choose based on their interests and abilities.

Finnish group will have young people with mental disabilities and therefor need two group leaders to accompany them. The group leaders will help them to take part in the activities. They will have a detailed information before the youth exchange, and we will have pictograms on the walls with the schedule. Plus we plan more smaller breaks to the timetable to facilitate the needs of each participant.

All the little details will be addressed thoroughly in the APV.

Estonian group has young people with difficult economic and social backround. Also living on the Muhu island comes with geographical obstacles, you are dependent on ferries and the weather. The island is also far from bigger cities, with more opportunities. Estonian group leader is making sure, that the youngsters, that want to participate, can do that. If necessary, she will work with a social worker, to ensure that the youngsters can take part in the youth exchange near their home.

For Latvian partner the following measures will take place:

- before the youth exchange, during planning visit the place of actual youth exchange and accommodations will be visited, to evaluate the risks and necessary adjustments needed to make, like marking steps, glass windows or columns that blend in the background.
- before the youth exchange all participants and assistants will have at least one meeting to talk trough the plan of youth exchange and they will be familiarized with the premises by using descriptions
- before the youth exchange each participant will be in contact with the group leader and project manager to talk trough existing worries and make sure, that everyone has everything they need
- during the youth exchange two assistants will accompany the group and help them with navigation, day-to-day tasks and participating in activities if needed.

For the Finnish partner:

- -before the youth exchange the participants will recieve answers to all their questions.
- during the APV photos will be taken from the facilities, where the activities will take part and the participants will get to know the surroundings beforehand.
- -the group will have two group leaders, to help them take part in the activities and address all concerns

Preparation

Practical Arrangements

How will the practical and logistic matters of each planned activity be addressed (e.g. travel, accommodation, insurance, safety and protection of participants, visa, social security, mentoring and support, preparatory meetings with partners etc.)? Please also specify how the tasks will be divided among partners.

The exchange will take place on the island of Muhu (Estonia) in the village Liiva, that is the municipal center and biggest settlement on the island. The applicant organisation is in charge of the accomodation and the practical necessities during the project week. The participants will be accomodated in the camping site Aki with small houses 500 metres from the youth center, where all activities will take place. It is 200 metres from the bus station and local store.

Partner organisations make their own travel plans and help the participating youngsters with it. From Croatia, participants will be travelling by plane. Activity Title

Creativity is Confidence

Why do the participants want to carry out this activity? What issues and needs do they want to address?

Most of the participants want to experience the world of Erasmus+ for the first time. They want to come together and address the topic of confidence through creative processes. They want to obtain new skills to raise their own confidence and self powerment. For most of the participants it will be a first time abroad, and the biggest task within the youth exchange is to overcome the fears that are connected with new experiences. Music as a universal language will help the youngsters with different backrounds to come together and understand each others struggles.

What are the basic elements of the activity? Please describe at the very least the venue(s), working methods used, aims of each session etc.

The youth exchange will take place in Muhu Youth Center at the end of June and beginning of July. The participants will be accommodated 500 metres from the youth center in camping houses. The youngsters will learn by doing. They will use the open room method to address the subject of confidence. They will learn to create music and then they will create music and record it. Participants will also have a first glimpse into making a video. They will learn by doing, how to film a music video and how to edit it later. There will be reflection every evening to really understand, what they achieved during the daily activities.

Please describe the role and involvement of the participants from each participating group in all phases (planning, preparation, implementation of activities and follow-up).


The young participants are choosing the activities within the youth exchange. They also have a big input in the timetable. Since it's a youth exchange the biggest involvement will be during the week in Muhu. The youngsters will be in charge of their own learning and reflection. They will do the recording, filming, editing and sharing the result. They will be in charge of breakfast and time management. After the exchange they will do the dissemination within their social networks. The group leaders role is to support the youngsters and let them do as much on their own, as possible.

How will the groups of participants cooperate and communicate between them to prepare and follow-up on the Youth Exchange?

The group mainly communicates through group leaders with each other, since there are youngsters with disabilities and different obstacles involved. Before the youth exchange a facebook page will be made, where the participants can get to know each other. The facebook page will also help them to reflect, disseminate and keep contact after the youth exchange.

Their group leader is a youth worker, who works with the group daily. The Latvian group consists of youngsters with sight disabilities, 2 assistants and a group leader. The group leader is the project manager in the Latvian Blind Society. The Croatian group consists with active members in the organisation. Their group leader is a former active youngster, who has experience in Erasmus+ projects. The Estonian group has participants with different social, economical and geographical obstacles. The group leader is the manager/youth worker in the local youth center. The participants will be from ages 16 until 30 years old. Gender balance will be ensured in the selection process of the participants.

What will the participants learn about the chosen topic of the activity? Which learning outcomes or competences (i.e. knowledge, skills and attitudes/behaviours) are to be acquired/improved by participants in the activity?

The participants will learn about self-powerment. About overcoming their own set barriers to accomplish new things. How to make music and show it to the others. New set of skills and knowledge will include creating music, creativity, recording, filming, editing, time management, english language, intercultural awareness, consideration toward others. The participants will also learn about self- reflection and learning to learn.
