With this decision, the Regional Council of South Karelia approves the project for funding from the South-East Finland – Russia CBC 2014–2020 Programme.

INTERMEDIATE MEASURES

The Joint Monitoring Committee (JMC) of the South-East Finland – Russia CBC 2014–2020 Programme has approved the project for funding in its meeting of 18/12/2018, with the final quality score of 168,34 out of maximum of 200,00.

CONTENT OF THE PROJECT AND TERMS OF FUNDING

The amount of funding for the project is 681 973,00 euros, at the most, covering 80% of the eligible costs of the project. The funding granted for the project, the eligible actions, and other terms related to the project funding shall be specified in a separate grant contract, which shall be concluded between the lead partner of the project and the Managing Authority of the Programme.

APPEAL
