ANNEX 1 – Support Partnership Agreement

BACKGROUND

The Parties have entered into a memorandum of understanding concerning bringing HIMSS/Health 2.0 leading European Conference to Finland and organise it at Messukeskus during the next three years.

The Parties have finalised the negotiations and wish to document their mutual agreement in this Agreement.

THEREFORE, THE PARTIES HAVE AGREED AS FOLLOWS:

1. HIMSS and Messukeskus have agreed to organize the HIMSS European & Health 2.0 event (“Event”) exclusively in Finland in 2019 and in acting in good faith, the parties’ current intention is to renew this Agreement on similar terms for 2020 and again for 2021. Formal agreements concerning the venue will be signed once this Agreement is signed (or renewed for future years). Any renewal shall take effect only where the agreement concerning the venue becomes binding.
2. Sitra, Business Finland, City of Helsinki, University of Helsinki Medical Faculty, Helsinki University Hospital, The Ministry of Social Affairs and Health, Turku Science Park and Business Oulu agree to procure annually for each year of the Agreement suitable premises from HIMSS for the Event with the cumulative annual amount of €400k + VAT. The commitments for each party are defined below:
 - Sitra 100k€
 - Business Finland 100k€
 - University of Helsinki Medical Faculty and Helsinki University Hospital 50k€
 - City of Helsinki 60k€
 - Ministry of Social Affairs and Health 50k€
 - Turku Science Park Oy 20k€
 - Business Oulu 20k€

The failure of one of these parties to procure premises shall not release the other parties from their respective obligations. All rights are reserved in such cases.

3. **Timing.** Dates for the congress will be 11.-13 of June 2019. The dates for 2020 and 2021 will be mutually agreed.
4. The interpretation, validity and performance of this Agreement shall be construed and governed by Finnish laws. Any dispute, controversy or claim arising out of or in connection with this Agreement shall be finally settled by arbitration under the rules of the Board of Arbitration of the Central Chamber of Commerce of Finland. The arbitration tribunal shall consist of one (1) arbitrator. The arbitration shall take place in Helsinki, Finland. The arbitration shall be conducted and the arbitration award shall be given in the English language.
