# Objectives and activity plan

## **Objectives**

Objective 2: We want to be active learners and share knowledge on the European youth field. We want to share and get knowledge on new trends among youth and youth work in Europe. We want to enlarge our network and do stuff mobilities to learn more of youth trends and issues. Knowledge sharing, cooperation increases the quality of youth work. Half of the stuff mobilities would be applied by the youth workers according their needs and other half are chosen by the executive team, so we can learn from European on current issues and trends in the youth work. The model to safeguard the interests and make an impact on living conditions of the youth is relevant in these projects and the result will be seen also in better quality and more cooperation in the youth work.

Objective 3: To assure the youth can make a wider impact in EU and youth work issues, that concern them. We want to provide youth possibilities to be active European citizens, to do joint projects, learn from each other and get European friends. Participatory projects can also safeguard the interests and make an impact on living conditions of the youth. The models in participatory projects are to inspire youth to be active citizens, to make an impact and do their independent activities and to do youth work with groups and communities.
